**NOTES :**

1.\* Investments are stated at market / fair value at the Balance Sheet date / valuation date. In valuing the Fund's investments :-

- Securities listed on a recognised stock exchange, including dematerialised securities, are valued at the last quoted closing price on the principal exchange on which the security is traded. If no sale is reported, the previous quoted price is used, when it is not more than thirty days in case of equity shares and fifteen days in case of debt securities prior to the valuation date.
- Securities not listed on a recognised stock exchange for which over-the-counter quotations are readily available, are valued at the mean between the last current bid and asked price.
- Non-traded / thinly traded equity securities, including those not traded within thirty days and non traded / thinly traded debt securities including those not traded within fifteen days prior to the valuation date, are valued at fair value as determined by MSIMPL in accordance with the guidelines for valuation of securities for mutual funds dated September 18, 2000 and amendments thereto, as applicable issued by the Securities and Exchange Board of India and approved by the Board of Trustees.
- Privately placed securities are valued at fair value as determined by MSIMPL in accordance with the guidelines for valuation of unlisted equity shares for mutual funds dated May 09,2002 issued by SEBI and approved by the Board of Trustees.
- Equity shares awaiting listing are valued at fair value/application price as determined in good faith by MSIMPL in accordance with procedures approved by the Board of Trustees.
- Privately placed equity shares of listed companies with lock in period are valued at fair value as determined in good faith by MSIMPL under procedures approved by the Board of Trustees.
- Instruments bought on 'repo' basis are valued at the resale price after deduction of applicable interest up to the date of resale.

Debt Securities are classified as non performing assets and provision has been made in respect thereof in accordance with the guidelines for identification and provisioning for non performing assets (debt securities) for mutual funds dated September 18, 2000 and amendments thereto, as applicable issued by SEBI.

Following the issue of the guidance note on accounting for investments in the financial statements of mutual funds by the Institute of Chartered Accountants of India (pursuant to the Eleventh Schedule of the Regulations) net unrealised appreciation / (depreciation) in the value of investments is determined separately for each category of investments. Further the change in net unrealised appreciation / (depreciation), if any, between two Balance Sheet dates/ valuation dates is recognised in the Revenue account. Unrealised appreciation is reduced from the distributable income at the time of income distribution. At the end of the financial year, the balance in the revenue account including change in the net unrealised appreciation or depreciation in the value of investments is transferred to revenue reserve.

- For the period ended March 31,2008 Morgan Stanley Growth Fund has invested 1.78 % of it's Total Net Assets in American Depository Receipts / Global Depository Receipts of Indian companies.
- Disclosure Under Regulation 25(8) of the Securities And Exchange Board Of India (Mutual Funds) Regulations, 1996 As Amended.  
During the half year ended March 2008 Morgan Stanley Investment Management India Pvt Ltd (MSIMPL) has not utilized the services of the Sponsor or any of its affiliates, employees or their relatives for the purpose of any securities transaction as specified under Regulation 25(8) of SEBI Regulations. However, during the period the Fund subscribed to the issue of equity shares of the following companies where Morgan Stanley India Company Private Limited (formerly known as JM Morgan Stanley Private Limited), an associate of MSIMPL was the lead manager/co-manager to these issue. The subscriptions were made through non affiliate entities as given below.
